## Clinician – Roundel Residential at Good Will – Hinckley \$10,000 Sign-On Bonus

Do you want to work for an organization where you can make a difference in a youth life and with the ability to work a flexible schedule? Good Will-Hinckley is looking for a motivated and energetic team-oriented Clinician to join the Roundel Residential Program on its Hinckley campus. This position provides direct therapeutic services to students and clinical oversight of the Roundel Residential Program with a workload of up to 5 to 6 youth. Responsible for ensuring delivery of quality clinical services to youth and families, creating and monitoring treatment plans and compliance with all state and federal mental health licensing standards and MaineCare regulations.

The Roundel Residential Program serves boys and girls ages 12-21, in a therapeutic setting. The program uses a trauma-informed approach to provide youth-centered individual and family counseling, case management services, academic programming, life skills and positive youth development activities to address behavioral health challenges.

The focus of these individualized services is to first stabilize behavior and identify triggers that cause youth to lose control. As treatment progresses, youth build unique coping skills enabling them to become productive members of their homes, schools, and communities.

Those completing the program and successfully returning home have been some of the highest-risk youth in Maine. In many cases, students who complete the program do better in school, are less likely to commit a crime, become more successful members of the community and have more successful relationships with their families.

## Our Program

Using the relational model, Collaborative Problem-Solving, as well as Restorative Justice to make connections, the program does more than consider mental health. It creates holistic and authentic connections with youth, achieving a high success rate with this extremely vulnerable population.

Youth say the program has led them to greater self-awareness and has taught them how to communicate with others in a socially acceptable manner and return to the community setting.

## Services Provided

The foundation of the program is a comprehensive diagnostic assessment. A licensed team of treatment providers conducts these evaluations and reviews relevant psychosocial, developmental and medical information. This data is used to formulate the individualized plan that will be the focus of each youth's treatment while in the program.

The program also offers crisis stabilization and intervention, aftercare planning, and case management beginning on the day of admission. Aftercare services are also offered for up to six months after a youth returns to the community setting.

## **Qualifications:**

- Master's degree in related field.
- Proven treatment planning experience in MaineCare Sections 97 and 65 preferred.
- Licensed as LCSW, LCPC or LMSW or LCSW-cc or LCPC-c.
- Demonstrated clinical expertise in working with youth and families.
- Satisfactory reference, background, and health checks. Must have a valid Maine driver's license.

Benefits include a competitive salary (\$58K - \$65K); health, dental, long-term disability, and life insurance, Maine State Retirement, and 401K; Earned Paid Leave, and recognized holidays.
