Good Will – Hinckley has an immediate opening for a shared Ed Tech III/ certified to join the GWH team in our Roundel Residential (RR) and Glenn Stratton Learning Center Program (GSLC), located on our campus. The Shared Staff position is a year-round full-time hourly position, assisting and supporting youth with significant social, emotional and behavioral challenges in the residence and at school. Under the direct supervision of the Program Director (RR) and Program Manager (GSLC), this position is primarily responsible for the health, safety and welfare of youth, providing daily direct care and supervision in the ongoing implementation of the treatment plan. During school vacation, holidays and in the summer, these staff members will work in the Roundel Residential program. This position comes with a **\$1,000 sign-on bonus**.

SHIFT: Ed Tech III/BHP Shared Staff Monday through Friday 7:30am -3:30pm

The Roundel Residential Program serves boys and girls ages 12 and up, in a therapeutic setting. The RR program uses a trauma-informed approach to provide youth-centered individual and family counseling, case management services, academic programming, life skills and positive youth development activities to address behavioral health challenges.

Using the relational model, Collaborative Problem-Solving, as well as Restorative Justice to make connections, the program does more than consider mental health. It creates holistic and authentic connections with youth, achieving a high success rate with this extremely vulnerable population.

At GSLC, we believe that all students want to be successful in their home, school and community. Thus, our mission is to work collaboratively, using specialized educational services in guiding students with behavioral issues and backgrounds so they can experience success.

Students who attend GSLC have been referred through their school district's special education process. The student's Individual Education Plan (IEP) and clinical treatment plan serve as guiding documents throughout the school year. Students participate in a full academic and recreational day schedule. Additionally, GSLC offers specialized educational services catered to each student.

Minimum Qualifications:

- Ed Tech III Certification or able to get certification.
- Behavioral Health Professional certified or eligible to obtain BHP.
- Qualified applicants must have a clean background check with the Maine State Police, Department of Motor Vehicles and DHHS Child and Family Services.
- Reliable transportation that is insured in the state of Main and valid driver's license

Preferred Qualifications:

- Experience working in education, social services or a related field or College coursework in general or special education, psychology, sociology, or a related human services field.
- Experience working with individuals with significant social, emotional, and behavioral challenges.
- CPR/First Aid and Medication Administration Level 1 certified.
